1	Subject of decision/report title:	To approve variations to appointment of Arup including carrying out additional works to discharge pre-contract planning requirements; additional FBC support; post contract principal designer duties; post contract site supervision and engineering support.
2	Decision Date:	07 September 2022
3	Background/reason for decision/purpose of report:	Arup's initial approved contract total for Phase 1 amounted to £278,997.00, which was approved by (the then) Management Board and Transpot Executive Board in August 2020. Subsequent approvals to Arup's commission have resulted in a current total of £371,77 Arup's initial contract total for Phase 2 amounted to £111,383.00, which was approved by (the then) Management Board in October 2020. Subsequent approvals to Arup's commission have resulted in a current total of £119,838.  As the scheme has progressed, some additional items and tasks are required, which have arisen recently and were either unknown at the time of commission or outside the original scope. This is based on additional planning requirements and the need to extend the appointment to cover post contract Principal Designer duties and to continue with the design and supervision work and engineering advice covering the implementation stage.
4	Options considered:	Arup are so intrinsically involved in the current planning and design process; it is considered infeasible that an alternative consultant could pick up this work without causing further severe delay to this project.
5	Decision:	Approve an increase in the approval value for Arup's fees for Phase 1 of the scheme to undertake additional tasks from £371,776 to £505,021  Approve an increase in the approval value for Arup's fees for Phase 2 of the scheme to undertake additional tasks from £119,838 to £128,418
