2 - PROJECT DESCRIPTION

Bentley is a suburb of Doncaster that lies on the left bank of the River Don. Much of Bentley is within the low-lying basin and as such flood risk is dominated by the River Don to the south and Ea Beck to the north. Most of Bentley is designated as Flood Zone 3 on the Environment Agency's Flood Map for Planning which is described as land assessed as having a 1 in 100 or greater annual probability of river flooding.

Bentley has been affected by large scale flooding to residential, commercial and the highway network twice in the last 15 years, affecting the lives of over 2000 people locally and many more residents feeling the effects of the floods. The most recent event occurred in November 2019 were 326 properties experienced internal flooding. Flood events have been recorded at Bentley in 1854, 1932, 1939, 1947 and 2007.

In response to the November 2019 flooding events, DMBC and partners developed a catchment led partnership approach to flood risk, resulting in the South Yorkshire capital programme in which the Bentley scheme is identified as a priority project. The Bentley scheme is also identified as an action in the Connected by Water Plan launched in January 2022.

Following the November 2019 flood event, DMBC produced a section 19 report (Doncaster Council SECTION 19 FLOOD INVESTIGATION 11th September 2020), which identified several key areas and schemes with the potential to improve the drainage and minimize any future flooding within the area, which required further

study and feasibility. The scheme options identified within the section 19 report and additional options are currently being explored, incorporating the use of hydraulic modelling to identify the best value for money solution to provide increased protection to properties within Bentley Flood Corridor.

With this application, the applicant is seeking approval for £50k of MCA funding towards project development costs and to proceed to OBC/FBC for £1m towards the subsequent construction costs of the scheme. Project development activities to be funded will lead to identification of the preferred option which best achieves the project objectives and value for money.

3. STRATEGIC CASE	
Project rationale	The business case sets out clearly the impact and extent of flooding in the Bentley area, on residents, businesses and highways. Further information and quantification of the baseline flood risk in Bentley will be determined as part of project development activities, the results of which should be included at the next stage of business case development. Flood prevention is normally considered a public good that the private sector would be reluctant to fund, therefore requiring public intervention.
Strategic fit	The project has strong fit with the MCA's objectives to reduce flooding. There is also good fit with objectives including increasing business density, reduce carbon and personal wellbeing. For other MCA objectives the project claims to contribute to, there is not a clear or evidenced fit, or it is activity that is considered displaced/indirect.

4. VALUE FOR MONEY

Value for money will to be determined as part of the project development activities to be funded by this application. At this stage, the SBC presents high-level estimates, including area of land and number of residential and commercial properties to be protected.

The SBC sets out a clear and robust modelling methodology for the calculation of costs and benefits, and in determining the preferred option to be taken forward.

5. RISK

The project is at an early stage of development; however, key risks appear to have been identified with appropriate mitigation measures in place. All risks (apart from securing funding) are identified as having low likelihood. Most risks are identified as having Medium or Low impact, with the exception of 'failure to obtain legal arrangements in relation to land and right of access and ongoing asset maintenance' which is rated high.

6. DELIVERY

Key milestones appear reasonable.

Clear evidence of support from the promoting organisation is not provided. Reference to work to date, including a Section 19 investigation and existing modelling of the scheme is detailed as evidence of support for the project.

The SRO is identified as Paul Evans (Drainage and Streets Work Manager) who has signed off the business case.

No legal opinion in relation to subsidy control has been provided.
