#### **Executive Summary**

People in South Yorkshire are living shorter lives and in poorer health for longer than they should. Health inequalities within South Yorkshire are stark and despite our collective efforts, the gap is widening. As part of the Mayor's manifesto long term commitment to improve healthy life expectancy the Mayor committed to establishing a task and finish expert panel. The panel will advise the MCA, Local Authorities, the Integrated Care Board (ICB) and other partners what we could collectively be doing more of or differently to accelerate progress across South Yorkshire.

# What does this mean for businesses, people and places in South Yorkshire?

The expert panel will produce evidence-based recommendations for action to accelerate progress on improving healthy life expectancy and reducing health inequalities in South Yorkshire.

### 1. Background

- 1.1 Our economy has huge untapped potential but has consistently underperformed and we remain a low waged, low skilled, economy with resulting low levels of productivity and poor health. As such, The Mayor has identified health and wellbeing and addressing health inequalities as priorities for his Mayoral term and has set out a bold ambition to make our region the healthiest region in the country.
- 1.2 The Strategic Economic Plan sets out a vision for an economy that works for everyone, one that is stronger, greener and fairer. However, we will be unable to deliver a stronger economy if our population and workforce are unhealthy. We need an economy that reduces health and social inequalities and leads to people living longer, healthier lives. We want to create a virtuous circle of prosperity and health, where improved health outcomes support economic productivity and economic growth supports better health and wellbeing.
- 1.3 A whole system approach is necessary to create this cycle based on consensus, collaboration and a common and honest assessment of where the strengths, weaknesses, opportunities and threats lie. A task and finish expert panel will be created to advise the MCA, Local Authorities, the Integrated Care Board (ICB) and other partners on this approach. It will draw on the breadth of expertise inside South Yorkshire and bring in national and international experience, evidence and expertise to provide advice on the response to this challenge.
- 1.4 The Panel will have the involvement of each of 4 Directors of Public Health (DPH), both Universities, NHS representatives, the Voluntary Community and Social Enterprise (VCSE) and business representatives. It will also have the support of external expertise from the Health Foundation and Sir Michael Marmot's Institute of Health Equity. It has the support of the DPHs, the ICB Chief Executive and chair of the LEP.
- 1.5 The establishment of an expert panel is a manifesto commitment made by Mayor Oliver Coppard. The role of the expert panel is to advise the MCA, Local Authorities, the ICB and other partners what we could be doing more of or differently to accelerate progress across South Yorkshire to improve healthy life expectancy and reduce health inequalities. There is the potential of further complementary, exploratory work with the Institute of Health Equity, bringing in their experience on delivering Marmot Cities/city regions, to inform the South Yorkshire response.

### 2. Key Issues

2.1 There are stark inequalities in socioeconomic and health outcomes across our region. Too many people in the region are living shorter lives and experiencing poor

health at an earlier age. Life expectancy gains have stalled and even fallen for the most deprived communities.

2.2 The health of our local economy and the health of our population are interlinked and mutually dependent; one cannot prosper without the other. We know that poor population health and wellbeing is a drag on prosperity and productivity and a major reason why our economy struggles. A struggling economy contributes to fewer and less prosperous jobs, a reduction in wealth creation and investment and increasing deprivation.

## Appendix A

#### The Independent Expert Panel

The Mayor's Manifesto included a commitment to establish a panel of health experts. drawn from across the region, 'dedicated to driving that agenda forward with the urgency it demands'. On taking office the Mayor invited Professor Alan Walker, Co-director of Sheffield University's Healthy Lifespan Institute (HELSI) to develop a proposal for the membership and terms of reference of the expert panel.

#### Terms of reference

Mindful of the Mayor's emphasis on urgency and the existence of a rich evidence-base for action, including good practices in operation in Barnsley, Doncaster, Rotherham and Sheffield, the primary task of the Independent Expert Panel is to produce an action plan to extend Healthy Life Expectancy (HLE) and reduce inequalities in HLE outcomes. Therefore, the proposed terms of reference are:

- To take stock of the current relative position of South Yorkshire with regard to HLE and the extent of inequalities both within the region and in comparison to other UK regions.
- To identify the key priorities for action to extend HLE and reduce inequalities. In doing so the panel will draw on national and international evidence as well as existing good practices in the four authorities.
- To produce an action plan setting out the steps required to meet the goal of raising the health of the region to the highest possible level. The plan will:
- Establish a timeline
- Identify actions that could be taken immediately and can be actioned within current arrangements
- Identify actions that require further discussion and collaboration with local partners
- Identify actions that require further discussion and collaboration with Government

It is expected that the panel will co-opt additional expertise and commission specific pieces of work as required. It is also expected that the panel will produce its report within 6 months.

The University of Sheffield have agreed to support the expert panel through the appointment of a Post-Doctoral Fellow to gather and review data, evidence and information to inform the work. SYMCA will provide administrative and communications support and cover time and travel requirements of members.

### **Proposed membership**

The membership is intended to reflect expertise across the region while keeping the size of the group commensurate with the need for fast action. All of those contacted have agreed enthusiastically to join the group.
