C.1 CRSTS10 - York Road to Melton Road Trans Pennine Trail

Appendix C1 provides a summary of the project assurance and any suggested conditions of award.

The investment is for £0.35m from City Region Sustainable Transport Settlement (CRSTS) to Doncaster City Council towards total project costs of £0.804m

The project will see the installation of a sealed surface and widening along a much used section of Trans Pennine Trail (National Cycle Network) connecting users between York Road and Melton Road. The improvements will enable greater levels of active travel along an already busy corridor for people accessing employment, education and leisure.

Match funding has been secured from Sustrans to the value of £454,024

Following completion the outputs will deliver:

•1.6 km of new shared walking and cycling infrastructure

The overall objectives are to deliver:

- Improved connectivity for pedestrians and cyclists within Doncaster
- Segregated cycle facilities to enable more cycle journey stages
- Better connectivity for cyclists throughout the entire length of the routes
