This report is seeking approval for several investments, and to enter into contracts for each investment proposal, which will support the MCA's aspirations.

1. Background

- 1.1 This report seeks approval from the MCA Board for a project change request of one capital scheme, progression of three investment schemes and acceptance of one grant award.
- 1.2 Further details are provided on the proposals in the main body of the report.

2. Approvals

2.1 Sheffield City Council
City Centre Cycling / Cross City Bus
Transforming Cities Fund
In principle Approval

This project seeks £21.001m grant towards total project costs of £21.001m at an intervention rate of 100%.

In June 2021 the MCA board approved the OBC at a value of £14.3m. Subsequently the scheme has encountered several delays, increasing costs and a scope change.

The project has now progressed with procurement having completed RIBA3 stage and final prices are due imminently. Given the slippage in timescale and increasing value, the project has been assessed as an OBC to follow the current Assurance Framework.

The scheme will deliver integrated transport improvements across Sheffield city centre, so it is an easier place to travel to and from, whilst reducing the number of rips by car, further adding to the sense of place for the city and aligning to the aims of the Future High Street bid scheme on Fargate.

The scheme will include:

- the permanent relocation of public transport from Pinstone Street creating a pedestrian friendly environment.
- the creation of high-quality transport hubs on Rockingham Street and Arundel Gate to reflect the changing nature of the city centre.
- A kerb free pedestrian route for people travelling from High Street/Church Street to the Town Hall Square, Peace Gardens, Barkers Pool, Tudor Square and the Heart of the City II (HOTC2) will be created with widened footways where possible, to make it easier, more welcoming and safer for pedestrians.
- The proposals also include a number of bus priority measures (including bus gates) to reduce through traffic using Arundel Gate, Furnival Gate, and Rockingham Street constructed to be enforceable with appropriate signage and CCTV operation.

2.2 FourJaw Manufacturing Analyitics Ltd FourJaw Growth & Innovation Support Investment Zone Full Approval

This project seeks £0.28m grant towards total project costs of £0.54m at an intervention rate of 51.6%.

FourJaw Manufacturing Analytics Ltd were created four years ago from a spinout company at the Advanced Manufacturing Research Centre. The company's machine monitoring platform enables the monitoring of productivity and energy consumption of electrically powered machinery to aid manufacturers to identify and prioritise continuous improvement opportunities.

The company has grown since its inception and currently serves over 130 manufacturers in the UK and internationally and is now seeking assistance to move to larger premises in Sheffield and fund hardware which underpins its platform to support its continued growth.

The project will support innovation within the Investment Zone and create jobs within the region.

2.3 South Yorkshire Mayoral Combined Authority South Yorkshire Strategic Transport Model Full Approval

This project seeks an initial £2.9m to enable procurement, development, data collection, build and testing of the model. The total project costs are c£4.689m which will cover a 10-year period.

The project is a critical initiative aimed at improving the region's transport planning capabilities. The model is a vital tool for securing Department for Transport (DfT) funding and ensuring that regional transport plans align with national priorities, as the model provides the data-driven insights necessary for making robust investment decisions and demonstrating the value of proposed infrastructure projects.

The project will develop an industry-standard strategic transport model to simulate regional transportation patterns, forecast future demands, and inform long-term strategic decisions. This model will focus on large-scale transport dynamics, such as road networks and public transport systems, supporting major infrastructure planning and policy development.

While the strategic transport model will focus on large-scale infrastructure, existing tools such as the Active Mode Appraisal Toolkit (AMAT) and Cycling Level of Service (CLoS) will continue to be used to evaluate walking and cycling schemes, ensuring a comprehensive approach to transport planning.

The project includes the scoping of an active travel model. The development of the active travel model would be commissioned once the scoping is complete and will be integrated with the strategic model.

The initial funding will support:

- Procurement of contractors and technical experts.
- Data collection activities starting in March 2025.
- Development, calibration, and validation of the model.
- Scoping of Active Travel tools to complement the strategic model's capabilities.

3 Grant Acceptance

3.1 Higher Education Progression Partnership South Yorkshire

Uni Connect Partnership project Acceptance of £3,500 grant

SYMCA has secured £3,500 to develop a partnership project with HeppSY to further develop links between the South Yorkshire Careers Hub and regional universities. The project will fund a digital membership platform and support for students, fostering links with sixth form institutions to propel students from areas of low opportunities into top universities. The project aims to deliver an increased uptake in sixth form institutions' participation and increased university and apprenticeship applications among South Yorkshire students.

4 Project change Request Approval

4.1 Hybrid Air Vehicles (HAV) Contract Condition Change Request

The Hybrid Air Vehicles project was awarded a £7m loan by the MCA board in March 2023 with several conditions of award. All conditions prior to loan agreement execution have been met, however, to mitigate the risk of further delays to project launch and to make progress of Airlander in South Yorkshire the project is seeking to access £1m of the loan to enable critical path activities on the aircraft and site workstreams and allow more time for match funding to be raised.

HAV have deployed £1.2m into the project since February and continue to work towards match fund requirements.
